## HOW DO WE INVEST?

### Broad focus and large middle market opportunity set

U.S. middle market PE-backed companies with EBITDA of \$5MM to \$75MM

Broad industry coverage

First lien loans: mix of straight senior and unitranche. Selectively second lien, mezzanine and equity co-investments

Experienced PE sponsors

### Well established investment selection criteria

Pursue loans with unlevered yields of 6-8% (LIBOR+Spread+OID/3)

Conservative structure with appropriate loan-to-value and leverage ratios

All deals have at least one financial covenant and pay close attention to credit agreement terms

Seek lead, co-lead and agency roles

### Emphasis on portfolio construction, risk mitigation and ESG criteria

Diversified portfolio with an emphasis on granular hold sizes

Manage portfolio mix to emphasize products and sectors

ESG integrated approach, avoid binary risks and technically complex sectors

To promote alignment with LPs, NXT Capital, LLC (including its subsidiaries and affiliates, "NXT Capital") will hold a portion of each loan on its proprietary balance sheet
